## Consultation on the proposed status change for Crowan Primary School to amend age range

At Crowan Primary School we currently take admissions from the ages of 4-11 years. We are fortunate enough to now have the capacity to increase our intake and are looking to enrol children into an existing integrated nursery setting. By amending our age range to 2-11 years, this will enhance transition between Nursery and Reception Class and provide greater educational opportunities for children. We also envisage that the additional benefit of feeling part of a school community will allow greater educational consistency for our parents and families.
